

**CENTRALIA HIGH SCHOOL DISTRICT #200  
RANDOM DRUG TESTING POLICY**

No student will be allowed to practice, attend meetings, run for offices, or participate in any extracurricular activity until the consent form is on file at Centralia High School.

The following is a list of extracurricular activities that are covered by this policy. This list is not conclusive but, designed as a guide.

**The following groups will abide by the athletic stipulations and suspension policy:**

All Athletic Teams, Dance Team, Cheerleading Squad, Scholar Bowl, Flag Corps/Winter Guard, and Marching Band.

**The following group will abide by the non-athletic stipulations and suspension policy:**

Student Council, Spanish Club, Art Club, Computer Club, Lifesavers, Drama Club, Fellowship of Christian Athletes, French Club, Future Business Leaders of America, German Club, National Honor Society, Nike Club, Spanish Club, Peer Mediation, Sphinx Newspaper and Video Unit, Sphinx Yearbook, School Plays, Jazz Band, Pep Band, Swing Choir, all students wanting to buy a CHS Parking Permit, Homecoming (King, Queen, and Court), May Fete (King, Queen, and Court), Prom (King, Queen, and Court), etc.

**Any club, organization, or activity not mentioned in this policy will be at the discretion of the administration.**

**If a student is an athlete and also in clubs or organizations, then the said student must fulfill the suspensions contained in both policies (athletic and non-athletic).**

**The following stipulations apply to any positive test for all athletes. This policy is in effect for a student's entire high school career and is cumulative in nature.**

- A. Cause of suspension will be established by a "positive" drug test that is not satisfactorily explained.
- B. The student must have entered professional counseling and received a negative drug screen (**both at student's expense**) prior to resuming the suspended activity.
- C. If a suspension period included a fraction of an athletic contest and that fraction is .5 or higher, the athlete will **not** be allowed to participate in any part of that contest.
- D. All suspensions will be based on varsity contests. For example: If the student athlete's suspension consists of five contests, then the five contests will be varsity contests, even if the athlete only participates at the junior varsity or freshman level. He/She will **not** be allowed to participate until five varsity contests have been completed.
- E. Practice during the period of suspension will be up to the individual coach involved.
- F. An athlete's suspension will carry over to the next sport in which he/she participates. For example: If an athlete has a 20% suspension from football and only 10% of the season remains, then 10% of his/her next sports season would be suspended.
- G. Suspensions are only valid if the athlete finishes the sports season in good standing. For example: If a student serves all 20% of his suspension, then quits or is kicked off the team, the suspension is **invalid** and the athlete will serve 20% of the suspension the next sports season in which he/she participates.
- H. The percentage of the sports season will be calculated based on the regular season schedule. Individual contests will count as **one** contest and tournaments will count as **two** contests. In serving the suspension, the total number of contests an athlete is suspended from will be based on the number of actual contests completed. In cases of individual sports (wrestling, tennis, etc.), where there may be individual tournaments, the actual number of competitions will be counted based on the minimal number of matches in which the athlete could have participated.

**The following suspensions apply to positive test results for all student athletes.**

First Offense

20% of athletic contests of the sport in which the athlete is involved, which may carry over into the next sports season. Subparagraph F and G.

Second Offense

One calendar year suspension from all athletic participation from the date of suspension.

Third Offense

Suspension from all athletic participation for the remainder of his/her high school career.

**The following stipulations apply to all positive tests for all students participating in clubs, organizations, and other non-athletic activities. This policy is in effect for a student's entire high school career and is cumulative in nature.**

- A. Cause of suspension will be established by a "positive" drug test that is not satisfactorily explained.
- B. The student must have entered professional counseling and received a negative drug screen (**both at student's expense**) prior to resuming the suspended activity.
- C. All suspensions will be based on school day increments. For example: If the eligible student's suspension consists of thirty days removal from an activity, such as driving to school, then thirty school days must transpire before the student is eligible to be reinstated.
- D. A student's uncompleted suspension will carry over to the next school year. For example: If the eligible student's suspension consists of thirty days removal from an activity, such as driving to school, and only fifteen days of school remain, then the remaining fifteen days of the suspension will carry over to the next school year.
- E. Student's suspended from clubs and organizations will **not** be allowed to attend meetings, run for office, run for any elected position (class representatives, Homecoming, May Fete, etc.), or participate in any function of the group(s) until the suspension is completed. Students will be allowed to attend events, such as ball games and dances, but **not** allowed to participate and run for any elected positions.
- F. **In the case of May Fete, Prom, and Homecoming, a student that has been elected as part of the court, then tests positive, will not be allowed to participate as part of the court regardless of the length of his/her suspension.**
- G. Students who have their parking permit suspended are not allowed to drive on campus at any time, day or night, until the suspension is completed.

**The following suspensions apply to all positive tests for all students participating in clubs, organizations, and other non-athletic activities.**

First Offense:

Thirty day suspension from all extracurricular activities.

Thirty day suspension of student's school parking permit.

Second Offense:

One calendar year suspension from all extracurricular activities.

One calendar year suspension of student's school parking permit.

Third Offense:

Suspended from all extracurricular activities for the remainder of his/her high school career.

Suspension of student's school parking permit for the remainder of his/her high school career.

# CONSENT FORM FOR CONTROLLED SUBSTANCE TESTING

I/We have received a copy of the C.H.S. Dist. 200 Random Drug Testing Policy and have read and understand the policy.

I/We accept the method of obtaining urine samples, testing of each specimen, and all other aspects of the program as explained in the policy. I/We agree that the above named student will cooperate in furnishing urine specimens whenever requested within the specifications of this policy. Refusing to comply with the testing program will automatically deem the drug test as positive and subject the eligible student to the conditions and sanctions of a positive test as indicated elsewhere in this policy.

I/We further consent to the disclosure of sampling, testing, and results as explained in this policy.

This consent is given pursuant to all State and Federal Privacy Statutes and is a waiver of rights to non-disclosure of such test records and results only to the extent of the disclosure in the program.

***The signed consent of this form is valid through-out the eligible student's entire Centralia High School career. Parent/guardians have the right to withdraw their student from the Centralia High School Random Drug Testing Policy at anytime. Parents/guardians should request such a withdrawal in writing to the CHS administration. If a parent/guardian chooses to withdraw their student from the Centralia High School Random Drug Testing Policy the student will automatically be ineligible to join any club, organization, team, etc. or immediately be dismissed from such activity.***
